#### Description

Solriamfetol (Sunosi<sup>™</sup>) is a wakefulness-promoting agent.

### FDA Approved Indication(s)

Sunosi is indicated to improve wakefulness in adult patients with excessive daytime sleepiness associated with narcolepsy or obstructive sleep apnea (OSA).

Limitation(s) of use: Sunosi is not indicated to treat the underlying airway obstruction in OSA. Ensure that the underlying airway obstruction is treated (e.g., with continuous positive airway pressure (CPAP)) for at least one month prior to initiating Sunosi for excessive daytime sleepiness. Modalities to treat the underlying airway obstruction should be continued during treatment with Sunosi. Sunosi is not a substitute for these modalities.

#### **Policy/Criteria**

*Provider must submit documentation (such as office chart notes, lab results or other clinical information) supporting that member has met all approval criteria.* 

It is the policy of health plans affiliated with Centene Corporation<sup>®</sup> that Sunosi is **medically necessary** when the following criteria are met:

### I. Initial Approval Criteria

#### A. Narcolepsy (must meet all):

- 1. Diagnosis of narcolepsy;
- 2. Prescribed by or in consultation with a neurologist;
- 3. Age  $\geq$  18 years;
- 4. Failure of a 1-month trial of one of the following central nervous system stimulants at up to maximally indicated doses, unless contraindicated or clinically significant adverse effects are experienced: amphetamine immediate-release (IR), amphetamine, dextroamphetamine IR, dextroamphetamine, or methylphenidate IR; *\*Prior authorization may be required for CNS stimulants*
- 5. Failure of a 1-month trial of armodafinil (Nuvigil<sup>®</sup>) or modafinil (Provigil<sup>®</sup>) at up to maximally indicated doses, unless clinically significant side effects are experienced; *\*Prior authorization may be required for armodafinil/modafinil*
- 6. Dose does not exceed 150 mg per day.

### **Approval duration:**

Medicaid/HIM – 12 months

Commercial – Length of Benefit



#### **B. Obstructive Sleep Apnea** (must meet all):

- 1. Diagnosis of OSA;
- 2. Age  $\geq$  18 years;
- 3. Documented evidence of residual sleepiness despite compliant CPAP use as monotherapy for at least 1 month;
- 4. Failure of a 1-month trial of armodafinil (Nuvigil<sup>®</sup>) or modafinil (Provigil<sup>®</sup>) at up to maximally indicated doses, unless clinically significant side effects are experienced; *\*Prior authorization may be required for armodafinil/modafinil*
- 5. Dose does not exceed 150 mg per day.

Approval duration: Medicaid/HIM – 12 months Commercial – Length of Benefit

### C. Other diagnoses/indications

1. Refer to the off-label use policy for the relevant line of business if diagnosis is NOT specifically listed under section III (Diagnoses/Indications for which coverage is NOT authorized): CP.CPA.09 for commercial, HIM.PHAR.21 for health insurance marketplace, and CP.PMN.53 for Medicaid.

### **II.** Continued Therapy

- A. All Indications in Section I (must meet all):
  - 1. Currently receiving medication via Centene benefit or member has previously met initial approval criteria;
  - 2. Member is responding positively to therapy;
  - 3. If request is for a dose increase, new dose does not exceed 150 mg per day.

# **Approval duration:**

Medicaid/HIM – 12 months

Commercial – Length of Benefit

### **B.** Other diagnoses/indications (must meet 1 or 2):

1. Currently receiving medication via Centene benefit and documentation supports positive response to therapy.

### Approval duration: Duration of request or 12 months (whichever is less); or

2. Refer to the off-label use policy for the relevant line of business if diagnosis is NOT specifically listed under section III (Diagnoses/Indications for which coverage is NOT authorized): CP.CPA.09 for commercial, HIM.PHAR.21 for health insurance marketplace, and CP.PMN.53 for Medicaid.

### **III. Diagnoses/Indications for which coverage is NOT authorized:**

A. Non-FDA approved indications, which are not addressed in this policy, unless there is sufficient documentation of efficacy and safety according to the off label use policies – CP.CPA.09 for commercial, HIM.PHAR.21 for health insurance marketplace, and CP.PMN.53 for Medicaid or evidence of coverage documents.
